## Step 1

## Step 2

On receipt of your details, one of our lawyers will be in touch with you by email to organise a time to discuss your needs; whether that discussion is by way of a telephone call or by way of a video conference.

Both clients and our lawyers are finding video conferences are working very well during this period.

## Step 3

We will draft the documents and send them to you with a detailed explanation. We can then discuss any further changes that you need to make before you are ready to sign your Will.

## Step 4

When you are ready to sign, [new legislation passed by the NSW Government enables us to witness you signing the Will remotely](#) and make the Will valid.
